<p>Prayer or Relief Sought</p> <p>Respected Sir,</p> <p>Appellant emphasise his first appeal on certain below mentioned points: -</p> <ol style="list-style-type: none"> 1.Appellant filed an RTI bearing number POSTS/R/E/22/06427 on dated 13.05.2022. 2.Appellant received the answer of the abovementioned RTI on dated 16.06.2022. 3.Appellant satisfied with the answer given by respected CPIO for point number 1 that no central database is maintained for attendance for each postal employee. Hence no appeal for point number 1.

4. In point number 2 and 3, appellant sought the log in and log out time of employees of Head Post Office, Ghaziabad working in speed post, register post and payment banking services from 4 February 2019 to 9 February 2019.

5. Respected CPIO replied for point number 2 and 3 that requisite information is not available in compiled form. Hence Information cannot be provided.

6. Here, CPIO failed to mention proper section of Right to Information Act 2005, in which he has denied the information sought.

7. Secondly, respected CPIO earlier provided the same information sought regarding the Noida Head Post Office vide RTI number POSTS/R/E/22/02614.

8. How is it possible that the information sought is available for 1 post office and not available for the another one.

Therefore, I request the First Appellate Authority to take cognizance of this first appeal and issue a direction to the CPIO to provide the information sought in point number 2 and point 3 like he provided earlier in RTI bearing number POSTS/R/E/22/02614.
