<p>Prayer or Relief Sought</p> <p>Respected Sir,</p> <p>Appellant emphasise his first appeal on certain below mentioned grounds :-</p> <ol style="list-style-type: none"> Appellant filed an RTI to Delhi Transport Corporation bearing number DODTC/R/2022/60290 on 26-05-2022. RTI of the Appellant was transferred to Transport Department bearing number DOTPD/R/2022/80165 on 31-05-2022. RTI of the Appellant was again transferred to Public Works Department bearing number PWDPT/R/2022/80122 on 10-06-2022. On 10-06-2022, RTI of the Appellant was again transferred to Public Works Department (PWD) - Engineer in Chief bearing number PWDEC/R/2022/80377 on 10-06-2022. On 20-06-2022, RTI of the Appellant was transferred by Public Works Department (PWD) - Engineer in Chief to PIO Circle North East vide RTI number PWDEC/R/2022/80377/1. PIO Circle North East while disposing of the request on 21-06-2022 stated that the information sought in this RTI does not comes under the jurisdiction of this office. Here the RTI of the Appellant has been circulated like a football by all the PIOs. Even after transferring the RTI so much, the requested information was not given to the appellant.

9. If the sought information does not come under the jurisdiction of the office of PIO Circle North East then he has to again transfer the RTI to the concerned PIO under Section 6(3) of the RTI Act.

10. But PIO Circle North East settled the RTI without putting his mind to it saying that it does not come under jurisdiction of his office.

11. This amounts to the gross violation of the RTI Act.

Therefore I request the First Appellate Authority to take cognizance of this First Appeal and direct the PIO concerned to provide the information sought as soon as possible.
